Hi Nick,

My name's Melissa and I'm interning at the IACID. One of my projects is to work alongside Charles to update the website. Unfortunately the website is giving me a 500 error when I try to log in. It loads from browsers that haven't logged in to the Admin panel, so the public can still see it. But as soon as I try logging in it gives me the error.

Here is what I think may be the problem: This morning I installed and activated a plugin called Theme Test Drive to let us test themes without changing the public version of the website. I was able to test two or three themes this way, but when I tried to test the next one I got the 500 error and nothing has worked since then.

I've spent a few hours trying different solutions and trying to figure out what to do, and I think we need to go into the FTP files using a program like FileZilla or Cyberduck (the one I've downloaded to my Mac). Then we can delete that plugin, which is hopefully what is causing the problem. However, I don't have the FTP login info which apparently is emailed to the creator of the website upon creation.

So my questions are: 1. Do you have the FTP login info? 2. If so, would you want to send it to me to figure out or would you like to resolve the issue (I'm assuming you have far more experience with this sort of thing)?

I've copied Charles on this email so he's aware. I apologize for creating this problem (assuming that the plugin I installed is the issue; I've read it could also have to do with memory limits).

I have deactivated the plugin from the server side. It appears that it was the problem, some plugins can have adverse side-effects, especially with the itemes security. I would recommend that we come up with an evaluation process of sorts for any new plugins as many are poorly written and can have critical impacts on performance. In addition I would not install any new plugins until we've done so.

Is there a reason that we would be testing new themes, is there some functionality that the Divi theme is not providing?
